### **GENERAL BUSINESS:**

Alan Cole spoke about the Auckland Council budget challenges and how it was hoped that there may be funding available for community halls after July. Re-conditioned security cameras are also available through the Pukekohe Business Association which could be used for the hall. Ian Farrant asked Alan Cole what the Council needed from the Committee in order for the hall to be eligible for funding. The response was that we

Alan Cole said that there were in discussions with Counties Energy with regards to the supply of emergency generators and that local CD plans were now being prepared as these had ceased to exist when Auckland became a Supercity.
